# **Competencies for Mass Decon Operational Personnel**

The Mass Decon Operational personnel must be competent in the following areas:

Planning and response, selection of protective equipment, the understanding of decon procedures and perform functions, be able to evaluate progress/effectiveness, termination of procedures and meet all competencies of the Awareness level all core competencies of the awareness level chapter 5, all mission specific competencies for personal protective equipment (section 6.2), and all competencies in this section. Must work under the direction and supervision n of a Hazardous Materials technician.

## Planning the Response (Ref. NFPA 472-6.3.3)

- Selecting personal protective equipment for the mission specific under the guidance of the Hazardous Materials technician.
- Personnel should be able to identify and describe advantages and limitations for mass decon decontamination procedures to include isolation, dilution, and washing.
- Have the ability to recognize resources needed to determine the appropriate mass decon procedure.
- Have the ability to recognize what equipment will be needed for mass decon and how to implement it.
- Have the ability to communicate with crowds using procedures, equipment, safety precautions and crown management techniques where a large number of people may be contaminated.

#### Implementing the Planned Response (Ref. NFPA 472-6.3.4)

- Demonstrate mass decon duties outlined by the incident action plan in accordance with local procedures for ambulatory and non-ambulatory patients.

### **Evaluation of Decon Effectiveness (Ref. NFPA 472-6.3.5)**

- Have the ability to implement procedures according the IAP and/or AHJ to evaluate the mass decon procedures.

#### **Terminating the Incident (Ref. NFPA 472-6.3.6)**

- Have the ability to identify and describe reports and supporting documentation, importance of exposure documentation and records, activity logs, and document and records filing and maintenance under the emergency response plan and/or SOP's.

	Demonstrate the ability to implement a decontamination security area, personnel
	and equipment flow patterns, run-off, slop over, and over-spray to reduce cross
	contamination and extension.
