What's the Buzz? A Silver Jackets Update

The Florida Silver Jackets team is finalizing the Inland Resilience Guidebook for Highlands and Columbia counties. The team held a webinar to gather input from participating members in June and meetings with the counties to discuss the drafts were help in August. The last meeting will be held in September for final approval from the counties.

The team will also participate in a project led by the Environmental Protection Agency at Lake Martin in Bay County. This project will focus on rebuilding the area along Cherry Street, the main access point for the cities of Parker and Springfield. Currently, the street is prone to flooding from Lake Martin during high tides and heavy rainfalls. The project will to mitigate the risk of flooding to allow vehicles to pass through with greater ease and make the area more welcoming for recreational activities. The project will also support the Recovery and Resiliency Partnerships Project vision of helping communities recover from Hurricane Michael by leveraging a broad array of support from local, state and federal agencies. The Army Corps of Engineers will provide a hydrologic and hydraulic study in the project area to assess the water flow issues from Lake Martin.

FEMA Audio Project Captures Local Stories of Resilience

In May, the Federal Emergency Management Agency (FEMA) Region IX Office launched the *Level Up Audio Project*, a series of 10- to 15-minute conversations with local leaders on the West Coast who are making hazard mitigation a priority in their communities. The series was created to support local conversations about hazard risk and resilience, strengthen a network of hazard mitigation and climate adaptation professionals and inspire action. *Level Up* discusses many themes, including:



- Hazard mitigation
- Ecosystems and natural resilience
- Climate change
- Equity, environmental justice, social resilience; and more

FEMA partnered with the Georgetown Climate Center (GCC) to distribute *Level Up* to reach a broader audience. The partnership was born out of a shared desire to inform and empower State and local jurisdictions to reduce the impacts of natural disasters and climate change. While the podcasts use examples from Region IX, many of the themes are very relevant to Florida. Tune in to hear:

- The City of Tehama stacked various funding sources to elevate homes and protect the community from floods
- The Solano County Water Agency helped rural landowners mitigate flood risk by assisting them with permit applications for streambed work
- The City of Santa Cruz integrated climate adaptation with hazard mitigation planning processes to ensure more coordinated implementation
- An immigrants' rights organization made sure all members of the community were able to rebuild following the Thomas Fire; and more


